# Savings Account

## Star Saver Account

- ✓ A savings account with a high standard interest rate. Must be linked to an SCCU transaction account<sup>4</sup>
- ✓ \$0 monthly account fee<sup>5</sup> if you meet one of the following criteria: you are under 21 or account balance remains at \$3k or above or if you have \$30k or more in deposits and/or loans with us
- ✓ Make unlimited transactions without losing interest

Visa Debit declines & insufficient funds	\$0.60 per transaction
Visa Debit Card and/or Visa Debit Card PIN replacement	\$10 per card / PIN
Visa Debit Card and / or Visa Debit Card on Sub-accounts	\$10 per card for additional cards excluding the first card
Visa Debit cash advance (incl. international ATM withdrawals)	\$3.50 per transaction
Visa Debit chargeback and / or representments	\$30 per chargeback / representments
Visa Debit copy of voucher	\$20 per voucher
Visa Debit overseas emergency cash rejection	\$70 per request
Visa Debit foreign currency conversion (charged by Visa)	3% of international transaction amount
Visa Debit emergency overseas replacement card	\$250 per card
Visa Debit emergency domestic replacement card	\$40 per card
Visa Debit Disputed ATM/eftpos transaction (payable by customer if dispute declined)	\$30 per dispute

Agency withdrawal	\$20 per withdrawal
Coin handling (SCCU customers)	First \$100 free 5% of total coin thereafter
Coin handling (non SCCU customers)	5% of total coin
VIP Security token	\$25 per token established
Offset facility	\$0/NA for Business Loan and Personal Loans
Overdraft Annual Fee - Personal	\$120 per annum
Overdraft Annual Fee – Business	\$250 per annum
Dormant customer	\$15 charged quarterly
Copy of statement/s and/or transaction listing	\$2 per page a further \$1 if postage is required
Searching and/or checking customer transaction voucher/s	\$35 per hour or part thereof
Copy of customer and/or SCCU cheque	\$30 per copy
Accessing personal information under the Australian Privacy Principles	\$35 per hour or part thereof
Audit fee for all account audit requests by external parties	\$35 per hour or part thereof
External garnishee administration fee	\$13 payable on each garnishee amount
Company search	\$20 per search
