## Transaction Accounts

- ✓ Competitive interest earned on the balance<sup>5</sup> of the account

- ✓ Mobile and NetBanking — offering easy, fast and secure banking
- ✓ Free in branch cash deposits or withdrawals
- ✓ Links directly into Xero and MYOB accounting software

## Savings & Deposits Accounts

### Star Saver Account

- ✓ A savings account with a high standard interest rate and a bonus interest rate structure where certain conditions are met. Must be linked to an SCCU eligible transaction account<sup>3</sup>
- ✓ \$0 monthly account fee
- ✓ Combined Account balance capped at \$2.0 Million for business entities

### Little Star Saver Account

- ✓ A savings account with a high standard interest rate and a bonus interest rate structure where certain conditions are met
- ✓ \$0 monthly account fee
- ✓ Available to children aged 14 years old or younger
- ✓ Bonus interest is only paid on the first \$50,000

### Star Saver - Controlled Money Account (Solicitors Only)

- ✓ A savings account with a high standard interest rate
- ✓ Bonus interest rate offers available as detailed in our interest rate schedule
- ✓ Account balance capped at \$2.0 Million per account holder

### Term Deposits

- ✓ Funds invested for a fixed term period at an agreed fixed interest rate
- ✓ If you choose to withdraw from your term deposit before the end of its term you must give us 31 days' notice<sup>4</sup>.
- ✓ Combined Account balance capped at \$2.0 Million for business entities as defined in the product TMD
