<b>Mortgage Offset</b>	No direct interest is payable on this account however the daily credit balance is offset against the linked mortgage account, resulting in an interest reduction in debit interest charged to the loan.

Explanations	
<b>1</b>	Was able to be opened in child/children's name with Parent/Guardian/s as Authority to Operate (ATO), or in Parent/Guardian/s name in trust for child/children.
<b>2</b>	If you require a cash withdrawal in excess of \$10,000 you must provide 36 hours' notice to the branch where you wish to withdraw the amount. We reserve the right to limit cash withdrawals to amounts deemed reasonable by Southern Cross Credit Union.
<b>3</b>	Subject to cleared funds being available within account.
<b>4</b>	Available for Visa Debit Card holders. Maximum 10 transactions per day up to daily limit. Further transactions can be made via your card by inserting the card and entering your pin. Transactions \$100 and over will still require PIN to authorise transaction.
<b>5</b>	Larger NetBanking transaction limits may be available on request and with prior arrangement.
<b>6</b>	Overdraft available for approved applicants.
